## **COUNTY BOARD ACTION ITEMS:**

- 1. <u>Bridge Petition</u>: Esmen Road District Section, Repair south timber abutment of S.N. 053-3245, 2690N, 1400E. Estimated Cost = \$20,000.
- 2. <u>Bridge Petition</u>: Newtown Road District, Replacement of S.N. 053-3119, 780E, 2950N. Estimated Cost = \$250,000.
- 3. <u>Bridge Petition</u>: Round Grove Road District, Install scour mitigation measures under S.N. 053-3117, 3270E, 3100N. Estimated Cost = \$10,000.
- 4. Quarterly Report: 4th Quarter FY 13

COUNTY HIGHWAY DEPARTMENT RESTROOM FACILITIES: The highway department would like to get started on preparing plans for the rehabilitation of the existing restrooms in the maintenance and office buildings. The county board has authorized up to \$100,000 of capital improvement funds for the project. Due to department staffing levels and work load Winters requested the committee to consider outside consultant assistance to developed plans and bid documents for the work. Stan Weber recommended Middleton and Associates from Bloomington as a possible consultant to talk with. They were the involved with the renovation of the old county jail as well as the new jail. It was also requested that if it is feasible within the economic constraints of the project to design a storm shelter in the rehabilitation of the facility that the committee authorize this addition to the project. Winters stated that if the total package exceeded the upper limit of the capital funds, the highway department could possible use remaining funds from the Highway Wind Farm Account that are not obligated to a specific project at this time. The committee authorized the department to investigate these options to proceed with the project.

MANLOVE STREET STORM SEWER REPAIR – CITY OF PONTIAC: Winters informed the committee that the highway department recently participated with the City of Pontiac in the repair of an existing tile the runs on the west side of Manlove Street. There was a blockage in the tile that created basement drain backups in houses on the west side of Manlove Street. The tile also drains a portion of the Health and Education lot on Torrance Avenue. The City of Pontiac hired Opperman Construction to do the work and it was completed this week. The 50% county cost of the project was \$1,936.50.
